Hazardous waste or Scheduled Wastes are very toxic and dangerous. Improper management and handling of such waste will lead to series pollution of the environment and the ecosystem as well as immediate or long term impact to human safety and health.

According to the Waste Management and Minimization Compliance to Environmental Quality (Scheduled Waste) Regulations, 2005, "Every waste generator shall ensure that all his employees involved in the identification, handling, labelling, transportation, storage, and spillage or discharge response for scheduled wastes attend training programmes."

This same requirement for training applies to all employees of waste contractors involved in the handling, transportation and storage of scheduled waste.
